




# The power of XAI





# Automated approval flow

- Suggestions based on historical data
- Setting if suggested approval should be started or not
- Suggests first step by default, but if the invoice has always been approved by the same group of people, the entire approval flow can be suggested
- Uses supplier, department and project from invoice header as part of the evaluation
